On-farm prices are only for service calls provided by the Precision Ag Department, and do not cover service calls performed by the service technicians to calibrate, adjust, fix hardware issues, further diagnose Precision Ag issues, etc. All hardware-related issues will be taken care of by the service department, repairs will be charged at the normal hourly rate charged by the service department. Examples of hardware-related issues include, but are not limited to, broken wiring harness, failed sensors (moisture, mass flow, flow meter, steering sensor, etc.).



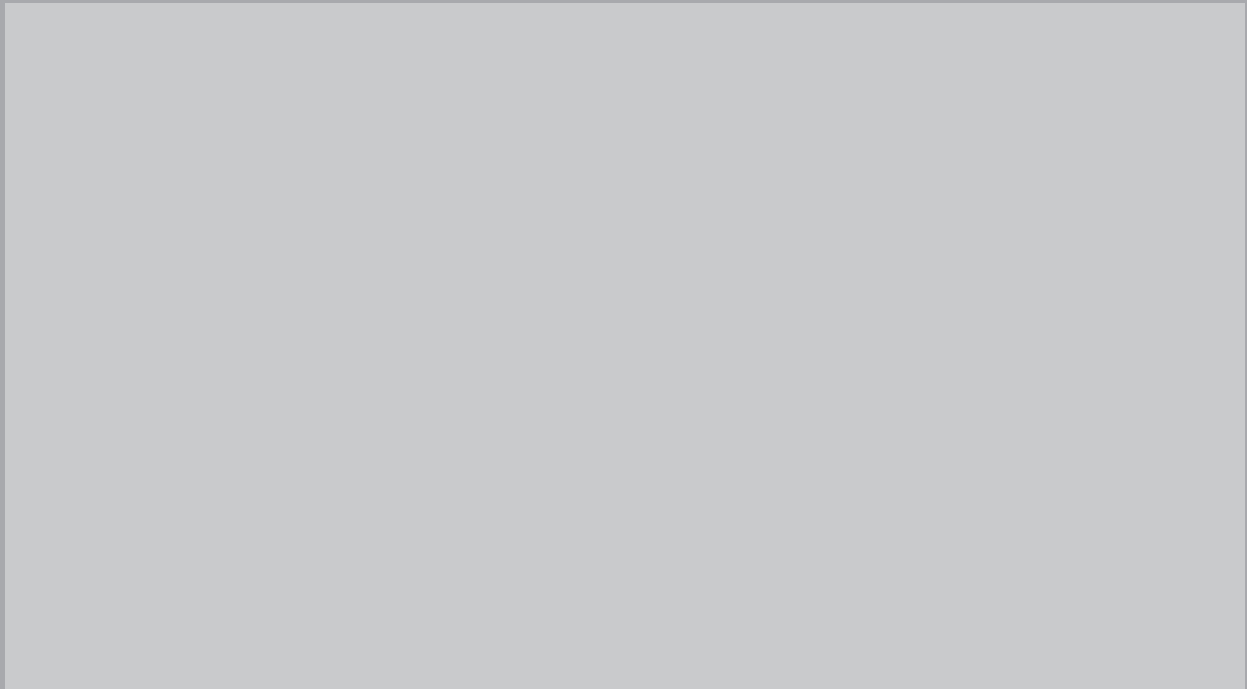

STANDARD TERMS AND CONDITIONING

ACCEPTANCE: These Terms and Conditions are hereby incorporated in and made a part of the Precision Agricultural Support Agreement between Stotz Equipment ("Supplier") and Customer to which these Terms and Conditions are attached (the "Agreement").

TERM: The Agreement shall automatically renew on January 1st following the Effective Date. The Agreement shall automatically renew thereafter for successive one-year periods unless Customer provides notice to Supplier that it elects not to renew. Such notice shall be provided no later than one month prior to each expiration date.

TERMINATION: Customer may, by written notice to Supplier, terminate the Agreement at any time. Upon such termination, Customer shall be liable to Supplier for payment for services completed prior to the date of termination. Supplier may, by written notice to Customer, terminate the Agreement at any time for any reason. In such an event, Customer shall be entitled to the return of any payments received by Supplier for services not rendered to Customer.

CONFIDENTIALITY: Supplier shall keep all proprietary and confidential information received from Customer in confidence and agrees not to use such information or disclose such information to any other persons except as may be reasonably necessary in connection with the services to be provided pursuant to the Agreement. Supplier shall not publicize Customer's name or the existence or terms of the Agreement without the prior written consent of Customer. Customer shall keep all proprietary and confidential information received from Supplier in confidence and agrees not to use such information or disclose such information to any other persons. This provision shall survive any termination of the Agreement.

SUPPLIER WARRANTIES: Supplier shall perform all services hereunder in a professional, competent and reasonably expeditious manner and in compliance with all applicable laws. Supplier makes no warranty express or implied. Fertility, crop protection, and crop yield, among other factors, may be affected by weather conditions, natural disasters, acts of God, and other events beyond Supplier's control. Customer acknowledges and agrees that Supplier does not guarantee any specific result from the utilization of Supplier services, including any specific fertility, crop protection, or crop yield.

THIRD-PARTY BENEFICIARIES: There are no third-party beneficiaries to the Agreement and the provisions of the Agreement shall not create any legal or equitable right, remedy or claim enforceable by any person other than the parties hereto and their permitted successors and assigns.

ELECTRONIC TRANSMISSIONS: The Agreement may be executed in counterpart and any signature page of the Agreement delivered by email, facsimile or other electronic format (including "pdf" or "tiff" format) shall be effective as delivery of a manually executed counterpart of the Agreement.

MISCELLANEOUS: The Agreement expresses the entire agreement between the parties concerning the subject matter hereof and supersedes any prior or contemporaneous written or oral agreement. The Agreement may be amended only by the issuance of an addendum executed by both parties. Supplier may assign or subcontract the Agreement or the services to be performed hereunder to an affiliate without the prior consent of Customer. The Agreement shall be governed by the laws of the State of Arizona.
